## Climate Justice & Children's Rights

*'[T]here may be no greater, growing threat facing the world's children – and their children – than climate change'<sup>1</sup>*

This year's ENOC Annual Conference will address the topic of Climate Justice from a children's rights perspective and will be the concluding event of ENOC's annual activities on access to climate justice. The urgency of addressing the topic of Climate Justice from a children's rights perspective stands from the disproportionate and devastating impact of environmental harm on children now and on their children in the future.

The Annual Conference will thoroughly address the main findings of ENOC's research on Climate Justice along with other contributions related to the conference theme. Over the year, ENOC members on one side, and the young people participating in the European Network of Young Advisors (ENYA), on the other, have worked intensively on the conference theme in order to provide valuable insights related to different aspects of Climate Justice. Among others, they have gathered information on existing and/or missing justice mechanisms (i.e., prevention, complaints, reparation, compensation mechanisms) that enable or prevent children and adults to enjoy a wide array of rights related to the environment. They also provided useful inputs and suggestions regarding children's engagement in climate activism, climate actions to mitigate environmental impact and child participation in environmental policy and decision-making. Remarkably, they stressed the pivotal role of human rights education, including the right to a healthy environment, as a way of empowering children to stand up for their rights.

ENYA young advisors will play an active role during the Conference by contributing and facilitating different plenary or workshop sessions. They will also present their policy recommendations on Climate Justice which will be reflected in ENOC's 2022 position statement on Climate Justice and Children's Rights to be endorsed by the ENOC General Assembly on 21<sup>st</sup> September 2022.

Ombudspersons and Commissioners for Children from across Europe and beyond, representatives of key European and International Governmental and Non-Governmental organisations, governmental authorities, professionals, experts, climate activists, and other stakeholders operating in the children's rights field are expected to take part in the event.

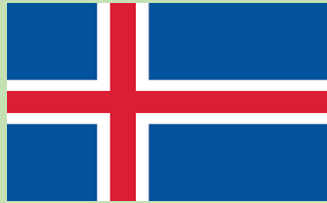
